## 5. Cleaning and Maintenance

The cleaning of laminated wood must be done with a soft sponge/sheet. Whereby stains persist can be used in a small amount of mild detergent and never abrasive or corrosive products. The cleaning of chrome and stainless steel parts can be made with a soft cloth moistened with alcohol, it is recommended to always dry well in order to avoid the persistence of halos.

## 6. Disposal

At the end of its life-cycle the furniture must be disposed in compliance with local regulation and, if possible, disassembled in several disposal according to its components.
